Please note this solicitation is not ready to be issued as of this date. The Embassy of the United States in Serbia will launch the solicitation on the Embassy website when it is available.

The solicitation will be for the maintenance services of the low voltage switchgear.

These requirements may change depending on funding availability in forth coming periods. Major duties and responsibilities are to provide preventive maintenance services the facility's main service electrical distribution switchgear at the U.S. Embassy in Belgrade, Serbia. The objective of scheduled preventive maintenance is to eliminate system malfunction, breakdown, and deterioration when units are activated/running. The main components are double ended switchgear, LV outdoor switchgear, paralleling switchgear and a main switchboard.

All responsible sources may submit an offer, which shall be considered. The Government plans to issue the solicitation in February 2022.

Prospective offerors are encouraged to register prior to the submittal of quotations/proposals.
